1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Generic

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

3. **Generic**

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

4. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

5. **Buyer Added Bid Specific ATC**

2) Only local sellers/suppliers from telangana state (local address) will be considered. Other state sellers participating in this bid will be not considered and their bid offer will be rejected/disqualified during technical evaluation.

3) **Jurisdiction:** in case of any legal dispute the jurisdiction will be in Hyderabad only.

4) Delivery Instructions:

a) Prospective Seller after getting the Contract, should initiate the Delivery of the items well within the stipulated Delivery Period not at the Fag-End of the DP nor during last hours of last date of DP.

b) The Seller should deliver the materials at the designated place and to the designated Consignee in working days and during office hours- preferably from 10AM to 4PM.

c) The seller should carry all required documents like Copy of the Contract, Copy of Amendment of DP (if any), Tax Invoice, All certificates like- Warranty, Conformance, Calibrations etc (if any).

d) THE SELLER IS STRICTLY INSTRUCTED NOT TO OFFER DELIVERY AFTER EXPIRY OF THE CONTRACT DELIVERY PERIOD. Items will not be ACCEPTED without valid DP.

e) The Seller is requested to note that Delivery Period is the Essence of the Contract & non-delivery of the items within Contract Delivery Period may attract LD and adverse Seller Rating. Hence, Seller should execute the contract within DP.

5) Bidders are also instructed to enclose detailed technical literature/specifications/catalogue of their products quoted along with their bids. In absence of those, the offer will not be considered.

6) Bids with-"best brand", "superior brand", "brand-na" will not be considered. Bidders are requested to mention clearly the name of the brand/make and model for which they are quoting in their bids (specially in BOQ bids).

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider.
